#### 1) GENERAL INFORMATION

The Cache Valley Transit District (Connect Transit) invites bids for the sale of one (1) **2008 Dodge Ram 2500 Truck with Snowplow**. The vehicle may be viewed **by appointment only**, Monday–Friday, 8:00am – 3:00pm, by contacting **Jody Kimball** at **435-752-2877**. All vehicles are sold "as is, where is" to the highest bidder.

# 2) SUBMISSION OF SEALED BIDS

Complete the Bid Proposal Form (attached). Submit sealed bids marked "SURPLUS TRUCK – Attn: Procurement Officer" to Connect Transit no later than 9:00am MST, November 17, 2025.

Late bids will not be opened or considered. Bids may be withdrawn before the deadline by written or verbal request. Connect Transit reserves the right to reject any or all bids or waive informalities. All bids are legally binding offers. If you are the highest bidder, you are obligated to complete the purchase and remove the vehicle in accordance with the payment and removal terms outlined below. The winning bidder will be notified within 1 business day after bid opening.

# 3) PAYMENT AND REMOVAL

• Minimum bid: \$9,000

- Payment: Full payment is due within 7 calendar days of award (by November 24, 2025) via Money Order, Certified, or Cashier's Check payable to Cache Valley Transit District.
- Removal: Buyer must remove the vehicle by November 24, 2025.
  - After this date, a \$50/day storage fee applies.

- Connect Transit's insurance coverage ends once the Bill of Sale is executed.
